#### What is Private Fostering?

Private fostering is when a child or young person under 16 years old (or 18 if they have a disability) is looked after for 28 days or more by someone who is not a close relative, guardian or person with parental responsibility. Close relatives include parents, step parents, aunts, uncles and grandparents. It is not private fostering if the arrangement was made by a social worker at Cheshire East Council or if the person looking after the child is an approved foster carer.

People become private foster carers for all sorts of reasons. Private foster carers can be a friend of the child's family, or be someone who is willing to care for the child of a family they do not know.
